Welcome to AISA Connect

It goes without saying that International Student Advisers (ISAs), and others working in the international student sector, are continuing to face a huge number of challenges in supporting international students.



Whilst as an Association we are keen to ensure that we do not overlook the wider welfare support remit to international students, immigration and particularly Tier 4 continues to dominate.

We have faced the introduction of 30 day vignettes, changes to academic progression, increases to maintenance funds, right to rent as well as the removal of work rights for students in FE with more changes on the horizon for Tier 2 and other work related categories. This is all against the backdrop of the Chancellor's Spending Review in which he has highlighted the vital importance of international students to the UK economy by setting a target to increase numbers by 50,000 by 2020.

It is also a difficult time for many of students from regions affected by the refugee crisis including those from Syria, Iraq and Libya. Staff may be seeing these students in the context of their worries about their options to remain in the UK after the end of their studies or needing leave of absence due to inability to concentrate on their studies due to the stress of financial and emotional worries. Balancing the compliance agenda with the humanitarian needs of these students has never been more challenging.

It is within this context we are delighted to announce our Annual Conference on 11 April 2016 whose theme this year is Compliance with Compassion: Challenges and Opportunities which is covered in more detail elsewhere in this newsletter.

I am pleased to say that as an Association we are continuing to grow with new members joining us to share the benefits of coming together at a regional level as well as having access to a national network through our conference and training. We do however acknowledge these are hard times for colleagues in Further Education who have been particularly hard hit by a series of immigration changes which have severely impacted on international student recruitment. Our membership is also low within Students' Unions which in part reflects the low numbers of immigration support posts in this sector.

We will be looking for new members to join our wonderful Executive Committee as we have a number of vacancies coming up from April 2016 and would like to encourage nominations from all our members but particularly from those in FE and SUs. Watch out for announcements in your in box. In the meantime if you would like to discuss joining the AISA Exec please contact me for an informal chat. All the Exec contact details are on our website.

Finally, just a heads up to let you know we are doing a membership survey to find out what you as members would like to see more/less of from AISA. We would love to hear from as many members and non-members as possible so that we can continue to develop our networks and services to best meet your needs.

AISA will then lead an open discussion regarding visa peak periods and how we can seek to improve our own processes and student experience. d) Supporting students in crisis. This session will led by Adrienne Clarke who is currently doing a major rewrite of the UKCISA Guide to Supporting International Students in Crisis. It will be an opportunity for advisers to share best practice on how to support students facing difficulties for example as a result of a range of financial, political crises or natural disasters.

Spotlight on... South East and London

33 AISA members from 21 institutions met at the regional meeting for South East and London at the

London School of Economics on 06 November 2016.

It was a packed meeting (both in terms of the number of people attending and the agenda). Discussion ranged across many topics including:

- The distribution of BRPs for those granted entry clearance.
- Academic progress, changing institutions and the mixed messages from PAMs about what was acceptable
- Impending landlord immigration checks
- Issues with the difficulty of getting refunds for overpayments and other issues with the Immigration Health Surcharge
- Impending new maintenance requirements
- Worrying refusal decisions on credibility
- Changes to guidance on how early CASs can be issued
- The possibility of new applications forms in the new year
- CASs for students re-sitting/resubmitting
- Very large numbers of Entry Clearance Errors

The membership of the South East and London region is very diverse. It includes private, public, small, large, FE, HE, old and new institutions. The South East and London meetings last half a day and include lunch. There's usually a social gathering afterwards.

Supporting students affected by the refugee crisis

With the crisis unfolding on a daily basis on our TV screens it is sometimes hard to think how we as advisers might contribute to helping students affected by the huge political turmoil back home.

Many universities are now ramping up their efforts to provide help by offering scholarships to asylum seekers. We are also dealing with the challenge of supporting students affected by the refugee crisis whether this be financial, emotional or legal.

For example, Sheffield Students' Union has brought in a Human Rights/Asylum lawyer to do a presentation to current students on options to remain in the UK on the basis of asylum/human rights. We have also published a specific web page aimed at such students which covers the support on finance, academic, immigration and general welfare matters: su.sheffield.ac.uk/student-advice-centre/immigration/refugees.

What is clear is that for many students asylum remains a last resort. Switching to a work visa is the objective for some of these students but with the proposed changes to Tier 2 this may become even more difficult. It may be time for government to consider options for these students to remain under discretionary routes as was the case with Libyan students in 2011 and latterly for Syrian students.

There is a special forum for such issues to be considered which is co-ordinated by the department for Business, Innovation and Skills known as the RISC Committee (Responding to International Students which brings together sector representatives including NUS, UUK and UKCISA.

If you are interested in these issues and supporting students more generally in crisis look out for the dedicated session at our Annual Conference on 11 April 2016.
